Track Day Declaration and Indemnity

I wish to drive cars and/or otherwise participate in the above event and receive driving tuition from you

I understand that the activity I am about to undertake is hazardous and that by participating in this event I am exposing myself to risk of being killed, permanently disabled or seriously injured. I understand that racing is prohibited and that the purpose of the day is to allow the participants to improve their skills and learn the handling and braking characteristics of the cars, which they are using.

I understand that any insurance carried by SafelyFast and/or the Promoter and/or the event location operator in respect of any liability which might arise out of the track day will be limited and that my own personal accident, motor, third party and public liability insurance (if any) is unlikely to cover me for my losses, liabilities or personal injury.

I understand the following:

1. SafelyFast and the event organiser may scrutinise participant's vehicles before permitting them on the track however it is completely the driver's responsibility to ensure the car is in a safe condition to be used on track. I understand SafelyFast has no control over the level of competence of drivers I may passenger with or other participants. I am aware and accept that other participants will be on the course at the same time.
2. SafelyFast whilst giving guidance on, and where required to, enforcing the rules and safety standards of the event location operator will not otherwise enforce track discipline or safety measures. I myself am responsible for the way in which I use the track and for wearing appropriate protective clothing.
3. SafelyFast and/or the Promoter and/or the event location operator may refuse me access to the track if my car or I infringe any relevant rules or regulations or appear dangerous.
4. That seatbelts and crash helmets must be worn at all times
5. If under the age of 18, my parent/Guardian has read this declaration and signed and printed their full name opposite my name to confirm agreement to it.

I declare:

- A I will satisfy myself (by sighting lap or otherwise) before taking part that the venue and track is acceptable to me with regard to its features and physical layout (unless prohibited to do so).
- B That any cars for which I am responsible and which I will use on the track are in good and suitable mechanical condition. I declare that my vehicle is safe, complies with regulations and is fit to use for the activity for which I have attended today. No claim of any kind including any damage to vehicles which I am responsible for will be made against SafelyFAST or any associated company or person.
- C That I hold a current full licence entitling me to use on the public roads in the UK a car of the size and type that I will be using on the track.
- D That I am fit, healthy and competent to take part. That my eyesight is adequate for track use (with lenses if to be worn). I do not suffer from haemophilia and have no history of epilepsy, colour blindness or any other medical condition that could affect my ability to take part in this event.
- E That I will not participate in the track day whilst under the influence of alcohol or drugs (prescribed or otherwise).
- F I have read, understood and will comply with all Circuit Regulations, any Supplementary Regulations & Final Instructions for this event given by the organiser and/or venue Owner.

I agree to make no claim against SafelyFast and their agents in respect of any loss or injury suffered by me during the track day and to indemnify them against their costs and losses arising out of any claim made against them by anyone to the extent that such costs and losses are attributable directly or indirectly to my participation in the event.

It is important that you read and understand this indemnity form and the terms and conditions that apply. If there is anything that you do not understand or do not wish to agree to them please discuss it with a SafelyFAST representative before signing.
